

Section I- Invitation for Bid (IFB)

Divisional Forest Officer, Publicity & Extension Division, Ranchi, Department of Forest, Environment and Climate change, Government of Jharkhand invites Expression of Interest (EOI) in form of separate sealed Technical & Financial Bids for supply, installation and commissioning of LED Display Boards (8x6Feet).

The Tenderer has to quote the price of the size of LED Display Boards along with the installation costs in the financial bid.

A complete set of Bid Documents may be downloaded from www.forest.jharkhand.gov.in or the intended can procure the same from the O/o Divisional Forest Officer, Publicity & Extension Division, Van Bhawan, Block-D, Doranda, Ranchi during the Office hour in working days by paying Rs.1000.00(Rs. One Thousand) only in the shape of Demand Draft from nationalized banks drawn in favour of the Divisional Forest Officer, Publicity & Extension Division, Ranchi payable at Ranchi towards the cost of tender papers.

Interested and eligible Bidders are required to submit the Technical and Financial Bids in two separate sealed envelopes. The Technical and Financial Bids should be accompanied by a bid security as specified in this Bid Document. The EMD of INR 25,000/-(Twenty Five Thousand Only) in favour of, Divisional Forest Officer, Publicity & Extension Division, Ranchi, (In the form of Demand Draft should be included in the same envelope containing the Technical Bid). The Technical and Financial Bids along with the Bid Security must be delivered to the Office of Divisional Forest Officer, Publicity & Extension Division, Ranchi on or before, 21-03-2018 at 5:00 PM.

The envelope containing the Technical Bid and the Bid Security will be opened on 22.03.2018 at 3:00 P.M. in the presence of Bidders or their authorized representatives who choose to attend. In the event of the date specified for bid receipt and opening being declared as a holiday for the Office, the due date for submission and opening of bids will be the following working day at the appointed times.

Section II- Eligibility Criteria

The Bidding is open to all qualified Bidder who fully meet the following qualifying requirements:-

- 1. The bidder should have executed orders for supply, commissioning of the LED Display boards (submit self attested purchase order/work order and work completion certificate issued by competent authority)**
- 2. The bidder should have turnover of 1(one) Crore during the last three financial years and must submit an attested photocopy of the turnover stated.**
- 3. The Bidder should have GSTIN registration.**
- 4. Bidder should have local office in Jharkhand. (submit self- attested documents)**
- 5. Bidder should be empanelled with DAVP, Govt. of India/IPRD, Govt. of Jharkhand (Document of Empanelment-Self attested).**
- 6. Bidder must submit Self attested copy of PAN Card of the Proprietor/Firm.**
- 7. Bidder must not have been blacklisted by any PSU's/Central or State Government / Court of Law (An affidavit may be submitted).**

Section III – Instruction to Bidders

(Terms and conditions)

- 1. The bidders will have to quote the price of the LED Display Boards along with their installation charges in the financial bid.**
- 2. The Supply and Installation schedule shall be within 20 days from the date of issuing of work order at the location as mentioned in the tender.**
- 3. In case of any discrepancy between rates mentioned in figures and words, the latter shall prevail. If there is any discrepancy between the unit price and the total price, the unit price shall prevail and the total price shall be corrected.**
- 4. The bidder whose tender is accepted has to supply the items within the stipulated period, as mentioned.**
- 5. Division Forest Officer, Publicity and Extension Division, Ranchi may for the EMD amount deposited if the bidder fails to supply the items in stipulated period.**
- 6. The EMD amount of unsuccessful Bidders will be refunded without interest after completion of tender formalities.**
- 7. The price bid shall be evaluated on L-1 basis.**
- 8. No representation for change of rate once accepted will be considered.**
- 9. The tender should be submitted in two cover system i.e. a: Technical Bid along with EMD and b: Financial Bid. There should be proper indication of the contents on each envelope.**
- 10. The Bidders shall seal the envelope No.1 Technical envelope and envelope No.2 Financial envelope in separate inner envelopes, duly marking the envelopes as “envelope No.1, Technical Envelope” and “envelope No.2 Financial Envelope”. He shall then place these two envelopes in an outer envelope. Both the inner envelopes and the outer envelope should be addressed to: Forest Division Officer, Publicity and Extension Division, Ranchi**
- 11. Any bid received by the Tendering Authority after the deadline for submission of bids prescribed by the Tendering Authority, will be rejected and/or returned**

unopened to the Bidder. The Tendering Authority will award the work to the Successful bidder whose bid has been determined as the lowest evaluated bid provided further that the bidder is technically eligible.

- 12. Bidders are strictly advised to submit the Details of full specifications along with warranty period with technical bid.**
- 13. The total price of the supplied items will be payable after submission of bill along with successful installation, at location.**
- 14. The supplier will have to assume onsite support of the supplied items.**
- 15. During the onsite warranty period of 3(three) years the bidder shall have to rectify/change free of cost any hardware/software defect on complete set.**
- 16. Bidder shall make available all the hardware/software needed to operationalize the LED Display Board.**
- 17. Bidder shall also be responsible for the onsite maintenance free of cost for one year.**
- 18. The bidder must ensure Electricity Connection from nearest connection point upto screen installation site. Bidder must also ensure that the Insulated Wire Cables of suitable core/thickness and Accessories & Appliance of best and Approved Brands have been used.**
- 19. Mainline Voltage Stabilizer of Suitable Capacity and Range shall be fitted with LED Display Board and Associated Accessories.**
- 20. Bidder should establish Central Controlling System at the special location at Van Bhawan, Ranchi Equipped with-**
 - Controlling mechanism from distance through LAN/INTERNET**
 - Shall have one Computer System with following specification :-**

- All the Screen's computers must be connected to the computer system at central controlling system at specified location at Van-Bhawan, Ranchi (This will be provided by department).
- One High Speed wired broadband internet connection and at least Two High Speed Wireless Broadband Internet Connection shall be provided to establish Remote control of display Board located at different places (Prospective Installation) from the location of Central controlling System. (This will be provided by department).
- Satellite TV(DTH) and Digital Connection along with LED TVs of atleast 32''. One Separate TV for Display of camera feeds from all the LED Display Board also to be installed (This will be provided by department).
- One Advance level Computer (i-mac or similar) for Designing and Editing purpose loaded with Professional Version of Software like Adobe Creative Suites(CS), Premier Pro, Photoshop, Illustrator, Adobe Audition, Final Cut Pro(FCP), CorelDraw etc. shall be provided in the Central Controlling System (This will be provided by department).

21. The LED Display Boards located at other places shall be controlled and operated from Central Controlling System which shall be established at the specified locations at Van-Bhawan, Ranchi. The programmes to be aired/displayed at different locations shall be managed from Forest Head

Quarters, Van-Bhawan, Doranda, Ranchi. Therefore, Each LED Display Board located at other places shall have Two High Speed Wireless Broadband Internet and One High Speed Wired Broadband Internet Connection (This will be provided by department).

- 22. The LED Display Board have programmed AUTO ON/OFF Device, Auto Scheduling Facility, Auto/Programmed Shutdown/Rebooting System and manual Remote Access Control System.**
- 23. 400 W High Power, 2-way line array speaker with Amplifier of reputed Brand shall be fitted with Every LED Display Board.**
- 24. The Display must have Features of Multi Advertisements in all possible formats like JPEG, MPEG.Txt, Web file, .bmp, .jpg, Media file viz. .avi, wma, .mov etc.**
- 25. The Civil Structure for installation of the LED Display Boards shall be erected by the department under the technical help and supervision of the bidder.**
- 26. Bidder should depute one person for carrying out necessary operations and for imparting training for at least two months from the date of operationalization of the Display Board.**
- 27. Joint Ventures /Consortiums are not allowed.**
- 28. All legal disputes are subject to the jurisdiction of Ranchi courts only.**
