

Department of Forests, Environment & Climate Change, Government of Jharkhand intends to carry out **DGPS/ETS SURVEY OF NOTIFIED FOREST BLOCKS & SUPPLY AND ERECTION OF STONE MONOLITHS** in various forest divisions of the state of Jharkhand.

Tenders are, therefore, invited from reputed agencies involved in such works. Interested agencies/organization may download the Tender document from the website www.forest.jharkhand.gov.in or may obtain the same from the office of the Deputy Conservator of Forests, Planning, Tribal Area, Block-C, Van Bhawan, Doranda, Ranchi-834002, Tel:-0651-2481161, during office hours on any working day 08.11.2018 onwards.

The agencies/bidders are advised to study the Tender document carefully. Submission of Bids shall be deemed to have been done after careful study and examination of the Tender document with full understanding of its implications. 

Invitation of Tender For

Selection of suitable agency for carrying out Forest Boundary Survey by DGPS/ ETS & supply and erection of stone monoliths for control stations.

1. The Tender notice published in Newspapers vide Tender Notice No. – 03/2018 is a part of this Tender Document.

1. Project Background

The Jharkhand Forest Department has decided to carry out DGPS or Electronic Total Station (ETS) or combination of both surveys of notified forest land and digitization of forest boundary to bring it to the GIS platform. Preparation of Geo-referenced map of cadastral sheet and Geo-tagged photographs of each boundary pillar and reading of each boundary pillar in geographic co-ordinate system- WGS84 datum of the respective Universal Transverse Mercator (UTM) Grid Zone. It is intended to undertake DGPS/ETS survey work to cover approximately **40000 ± 5000 (Forty thousand ± Five Thousand)** forest boundary pillars across various forest divisions of Jharkhand during the financial year 2018-19. The final number of boundary pillars to be offered for DGPS/ETS survey work will be decided at the time of award of work, and the same is liable to further change as per performance of selected bidders and the requirement by the technical committee of the department during the course of the year.

For undertaking the above task of geo-referencing of cadastral map, satellite data and digitization of forest boundary pillars, Jharkhand Forest Department needs support services from agency/ organization/company, having experience in the area of **Land Survey/survey of the forest boundary by using DGPS/ETS Technology**. The present requirement is for the precise determination of geo-coordinates of each boundary pillar, boundary of the forest area and supply of Geo-referenced maps based on Cadastral map.

2. Scope of work

- a) The Scope of work includes identification & demarcation of forest boundaries by DGPS/ ETS Survey wherever necessary and documentation of forest records including clear marking of forest boundary and preparation of Geo-referenced maps for approx. **40000 ± 5000 (Forty thousand ± Five Thousand)** forest boundary pillars under various forest Divisions of the state of Jharkhand.
- b) The agency will prepare and supply Geo-reference maps of scale 1:3960; same as that of Cadastral Map, along with report consisting of all the readings and photographs at each boundary pillar as evidence for notified forest land in GIS usable format in geographic coordinate system-WGS84 datum of the respective zone.
- c) Submission of RAW (for Rover and Base) as well as post processed/real time differentially corrected (for Rover) DGPS readings (along with source file, all errors charts and 1. Base line Reports/Triangulation Reports 2. Network Reports 3. Loop Closure Reports etc., whichever is applicable at each Boundary Pillar along the periphery of the notified forest land, in RINEX or native format (8 Decimal places in degrees for latitude and longitude including height above MSL and HAE in cm) with area and perimeter shall be submitted every week to GIS cell of Forest Department. The Bidders should submit processing report output in soft copy weekly.
- d) The survey shall be performed using DGPS in real time or post processed mode. However, the survey shall be performed using ETS in shadow areas and Cadastral map should be geo-referenced using GCPs collected by using dual frequency DGPS receivers.

- e) Moreover, the Geo-referenced maps should be superimposed on satellite imagery and is the responsibility of surveying agency to procure the satellite imagery from NRSC, Hyderabad.
- f) Field training about the procedure of the DGPS survey will be imparted to the field staff & officers of the concerned forest divisions.
- g) Scanning of all documents including Gazette notification of Forest land, Cadastral map, etc. shall be done by the agency.
- h) Supply and erection of RCC monuments of size 1.5m x 23cm x 23cm at each control point shall be done by the agency.
- i) The agencies are expected to perform following activities:
 - (i) Assigning the precise geo-coordinates of the boundary pillars in the forest area.
 - (ii) To make a close survey of all the boundary pillars and also survey and marking of the missing boundary pillars of the forest area using dual frequency DGPS in RTK mode / ETS from the temporary GCP and also the offsets like prominent rivers and any other natural feature may be marked.
 - (iii) To prepare and supply Geo-referenced data in .shp and .kml format.
- j) One set of hard copy of maps and readings of each location in MS Excel (latitude and longitude in WGS84 datum and height above MS level HAE in cm) certified by the respective surveyor/ Amin, Forest guard, Forest Beat Officer, Forest Range Officer, ACF and DFO should be submitted.
- k) At place of missing boundary pillar a pit of size 2'X2'X2' should be dug up and a 10 cm layer of charcoal be placed in the pit at the bottom. The Charcoal layer will be followed by a 10 cm layer of lime. Then a coloured (**half green and half red in paint**) wooden post of hardwood not less than 10 cm diameter and 5 feet height shall be firmly fixed vertically straight in the pit in such a manner that 3 feet of it is kept above the ground surface. The post will be numbered with the no. of Boundary pillar and DGPS readings will be taken by the forest personnel. Photographs of the post along with detail surrounding will be taken. In case temporary boundary pillar is found at the point of DGPS survey point then the GPS Co-ordinates should be written on the boundary pillar.
- l) The Agency will provide laminated **geo-referenced maps** of the villages showing important landmarks apart from the forest boundary pillar locations. The map shall also be overlaid with the latitude-longitude grid of proper intervals. In the margin a table showing the geo-coordinates of all forest pillar locations identified on the respective map should be included.
- m) The agency will submit **photographs** from four directions every week with geo-coordinates inscribed on them of each respective pillar location identified showing the identification rod installed as prescribed and in presence of one personnel each of the agency and the Forest Dept. personnel who should be in proper uniform.
- n) The bidder should procure geo-referenced ground control points from Forest Survey of India/Survey of India in certified copy and should submit to PCCF Development.
- o) After survey of the points of a particular PF the area of the PF should be calculated so that the area can be compared with the records available in the Divisional Forest Officer.

To maintain the accuracy of measurements using DGPS/ETS measures shall be taken as follows:

2.1 *DGPS Survey:*

 P.C.C.F. Dev.

- i. The Survey shall be carried along the boundaries which are invaria~~marked~~ by the concerned local forest staff, conforming to the notifications, cadastral maps or other documents relating to location and extent of the land.
- ii. DGPS readings at each station along the periphery shall be taken by a Rover with a minimum observation period of 20 minutes. The DGPS Rover data with base station / control point data shall be differentially corrected, if real-time DGPS is not used. In addition to DGPS readings, simultaneously Handheld GPS readings must also be taken at each location for comparison, with the same observation period of 20 minutes.
- iii. **Establishment of Base stations (Control Points):**
 - Base Stations to be fixed by Multi/Dual frequency DGPS receivers with Survey of India (SOI)/FSI ground control points as reference to be obtained by the surveying agency from SOI/FSI at village tri-junction points.
 - The minimum observation time for base station shall be 12 hours from nearest SOI/FSI ground control point.
 - Required number of Primary Control Points shall be established in such a way that the distance between the DGPS base station and Primary Control Point (P.C.P.) shall be less than 30 km (for dual frequency DGPS Rovers) and the distance between P.C.P. and rover shall be less than 5 km.
 - The panoramic view surrounding the Base Station as well as antenna location showing the terrain in near proximity should be digitally photographed (should be taken in three or four different directions) and documented.
- iv. Rovers of Dual/Multiple frequency DGPS receivers shall be within a radius of 30 km from the base station. In case Single frequency DGPS receivers are used they should be used within 5 km radius of fixed base station. Readings of boundary pillars shall be taken with a minimum observation period of 20 minutes to differentially correct the DGPS Rover data with base station / control point data.
 - 01. In case real-time DGPS rovers are used, the Dual Frequency DGPS with OMNISTAR XP/HP connection shall be used alone and reading taken when accuracy is within 25 cm.
- v. The height above MSL shall also be recorded for location and must be linked to HAE with GTS (Great Triangulation Survey).

2.2 *Total Station Survey*

- a. Follow the procedure detailed in Para 2.1. Each Boundary Pillar must be fixed from at least 2 known locations.
- b. Geo-reference the data using GCPs. (GCPs shall be collected using dual frequency DGPS receivers in real-time/ post processed mode as per procedure detailed in 2.1.)
- c. The desired accuracy is 5 mm/km, and angles to $1^\circ/3600^\circ$. The distance between the Total Station and the target shall not be more than 500m.

2.3 *Conditions to be observed for Survey*

- i. The survey shall be conducted with similar instruments as far as possible.
- ii. DGPS instruments used for survey must be set-in to **Geographic Coordinate System – WGS84 Datum.**

iii. RAW (for Rover and Base) as well as post-processed/ real-time corrected DGPS readings (for Rover) for location; and the Handheld GPS along with original source file for each Survey Station shall be submitted every week or as soon as the work is completed, whichever is earlier, to the GIS Cell (In case real-time DGPS is used, the RAW and the differentially corrected readings in real-time for each Survey Station along with error profile and charts must be submitted).

iv. For each area a unique ID shall be given. All the features shall be recorded in this ID.

All the features will be extracted from this data.

To deliver the output in the following formats

- i. The co-ordinate list (excel format) should be supplied both for geodetic system (Lat/Long up to 5 decimal of the second) and Projected System – Universal Traverse Mercator, i.e., the UTM projection (northing/easting/height up to 5 decimals) of the respective zone.
- ii. Forest Boundary Pillar survey point coordinate in a GIS format (.shp file).
- iii. Surveyed Forest boundary in GIS format (.shp file).
- iv. The agency should submit a field drawing of the survey pillar along with field photographs from 4 directions (E, N, S & W).
- v. Geo-reference cadastral map in .shp file.

Note:

The Geo Co-ordinate list and other attributes of all the boundary pillars along with GTS points shall be submitted to concerned DFO in the state of Jharkhand and cannot be used by the agency for any other purpose for which the agency has to submit a declaration. The locations and IDs of all the control points of surveyed forest boundary should be submitted by the agency.


Tender Notice documents shall comprise all the documents mentioned in the table of contents of this document. In addition to these any other documents/amendments/revisions or instructions issued by Department of Forest, Environment & Climate Change, Government of Jharkhand from time to time to bidders till due date of opening of the bids, shall also be deemed to be integral part of the tender document.

4. Bid Submission Procedure

- 4.1 Bidders are advised to submit their bids strictly based on the specifications, terms and conditions contained in the tender document and subsequent revisions/amendments, if any. The bids should be submitted along with covering letter as given at **Annexure-2**.
- 4.2 The bids shall be prepared and submitted by typing or printing in English on white paper in consecutively numbered pages duly signed by the authorized signatory with agency/firm/organization/company seal affixed on each page. Any part of the bids, which is not specifically signed by the authorized signatory and not affixed with Agency/firm/organization/company seal, shall not be considered for the purpose of evaluation. The bidder shall also enclose the information about bidding firm as per **Annexure-6**.
- 4.3 Original copy of tender document, amendments/revisions to tender document including minutes of meeting(s), issued by the Forest Department, if any, shall be signed and submitted along with the bids.
- 4.4 All the Proforma must be on the bidder's official letterhead (if specified). Any change in wording of the Proforma will not be allowed. The bidder shall submit a declaration as given at **Annexure-7**.
- 4.5 The bids shall contain no erasers or overwriting except as necessary to correct errors made by bidder. The person signing the proposal shall put his initial and rubber stamp on such corrections.
- 4.6 Complete bid document including all enclosures should be submitted in hard bond or spiral binding and all pages should be numbered (except leaflet/catalogue) and must be signed by the company's authorized signatory with seal of the company/firm/organization on each page.
- 4.7 The bidders should submit the bids in sealed envelopes. The Technical Bid and all supporting documents; and the Financial Bid shall be sealed in separate envelopes and respectively superscribed 'Technical Bid for Notice Inviting Tender for carrying out Forest Boundary Survey by DGPS/ETS & Supply and Erection of stone Monoliths' and 'Financial Bid for Notice Inviting Tender for carrying out Forest Boundary Survey by DGPS/ETS & Supply and Erection of stone Monoliths'. The envelope for Financial Bid must contain only the Financial Bid in prescribed Proforma, and no other document. Both these envelopes shall be sealed in a covering envelope superscribed "Tender Bid for Notice Inviting Tender for carrying out Forest Boundary Survey by DGPS/ETS & Supply and Erection of stone Monoliths". Tenders not conforming to these guidelines shall not be considered and will be summarily rejected.
- 4.8 Both these envelopes should contain address of the contact persons of the bidder firm and should be addressed to Deputy Conservator Forests, Planning Tribal Area, Block-C, Van Bhawan, Doranda, Ranchi, Jharkhand.
Both the above (Technical and Financial Bids envelopes) bids document should be sealed in a third envelope. The third envelope should be sealed and super scribed (i) Bids for DGPS/ETS survey of Forest boundary Pillars (ii) Name and address of the contact persons of the bidding agency should be written on the envelope and it should be addressed to Deputy Conservator Forests, Planning Tribal Area, Block-C, Van Bhawan, Doranda, Ranchi, Jharkhand Pin-834002.
- 4.9 Technical Bid should not contain price. Such document, even if found anywhere, shall not be given any consideration.

4.10 In case of any contradictions between figures and words, the words shall be considered final.

4.11 The Technical and Financial bids will be evaluated as follows :-

4.11(A) Stage- I: Technical Evaluation

The following is the Minimum Eligibility Criteria against which each Technical Bid shall be evaluated. The bidders must submit all supporting certified documents alongwith the Technical Bid. The Technical Bid Evaluation Committee reserves the right to reject the Technical Bid in the absence of relevant document/documents supporting a claim made by the bidder. All such bidders who qualify the Minimum Eligibility criteria will be taken as Technically qualified, and only their Financial Bid will be considered.

- a) The Bidder/Agency should have valid Service Tax registration/GST/State TIN Registration certificate and should submit a copy of registration along with copy of GST/TIN returns for 2017-18.
- b) The Bidder/Agency should submit a copy of the PAN card.
- c) The Bidder/Agency shall submit copy of the Certificate of registration of the firm/society/company (if any), in the name of Bidder/Agency.
- d) The bidder firm should have latest ISO certification for quality management and a copy of same should also be submitted.
- e) The Bidder/Agency shall submit undertaking/self-declaration that the proprietor/partner/Director of the bidding agency has not been convicted or charge-sheeted by a court of law and it has not been black listed as per the Proforma as given at **Annexure-13**.
- f) The bidder should be a functional organization/firm/agency. To substantiate this claim, the bidder should submit the copy of balance sheet for last three financial years, duly certified by the Statutory Auditor with his stamp.
- g) The bidder should be empanelled with ISRO/NRSC/SRSCS/FSI/SOI or any Govt. Department for undertaking DGPS Survey. For this propose the bidder should submit the relevant certificate issued by the competent authority.
- h) **Professional Experience: -**
 1. The bidder should have 7 years of experience of DGPS Survey with reputed organizations in India.
 2. The bidder should have surveyed atleast 50000 points or 5000 Sq.Km using DGPS in last 5 years (1Sq.Km will be construed as 10 survey points or vice-versa) of forest or non-forest area.

A copy of order/orders and certificate/certificates indicating their successful execution should be enclosed in the Proforma as given at **Annexure-14**. The bidder firm should have also completed such survey work within the prescribed time and for this purpose the details shall also be provided as per **Annexure-17**

- i) The company must have at least 20 Nos. of DGPS device out of which 10 devices should be dual frequency device. (Attach as a matter of Proof Purchase Bill /invoice & undertaking with list of device with Serial no./make/model etc).

j) The Bidder/Agency should have technical support comprising of minimum ~~minimum~~ twenty teams for this purpose. A Team will consist of professionally qualified 2- Surveyors, 1-DGPS/ETS operator and 1- team leader. The information about the technical man power shall be furnished by the bidders in prescribed proforma at **Annexure-15**. These technical persons should be on the payroll of the bidder. As a matter of proof, the bidder shall submit copies of EPF that cover contribution towards EPF certified by EPF Directorate during 2017-18 or Form 16 of Income Tax. In case there is no legal requirement of EPF or TDS of Income Tax, the bidder need not submit the details for columns 5 & 6 of Annexure-15.

k) The bidding firm should have minimum average annual turnover of INR 3 crore for last 3 (three) financial years (2015-2016 , 2016-2017 & 2017-2018) as per the proforma given at **Annexure-9**.

l) The bidding firm should have the net worth in excess of Rs. 3.0 crores (Rupees three Crore only). Original Auditor's Certificate must be enclosed. as per the Proforma given at **Annexure-10**.

m) Bidder would be declared technically qualified for the consideration of his/her financial bid (Financial evaluation) if the documents as listed in **Annexure-3** are submitted.

4.11(B) Stage-II: Financial Evaluation

(i) The bidder should submit the financial bid in Proforma as per **Annexure-5**. There shall be **no other document attached to the Financial Bid. The Financial Bid must include all admissible taxes, cess, fees, etc. and the Bid must not be conditional.**

(ii) The price evaluation would be based on L1 rates, i.e. the bidder with the least quoted price shall be declared eligible for award of contract.

(iii) The threshold technical support alone with tenderer declared L-1 may not be sufficient to meet the deadlines (after signing of agreement) of completing the tendered work satisfactorily within the stipulated time i.e. by 31-03-2019. In view of this, it has been decided that in the interest of quality of work and fairness in award of the tender, 60% of the total tendered work may be awarded to L-1 and the rest 40% of the tendered work may be awarded among L-2 and L-3 (20% each) at L-1 rate subject to their willingness.

(iv) In case, any selected tenderer fails to satisfactorily execute the agreement with the concerned Divisional Forest Officers in the stipulated time period, PCCF (Development) has the right to offer the same work to any of the Technically qualified bidders at L-1 rate, after taking approval of PCCF (HoFF).

(v) PCCF (HoFF) has the Authority to extend the contract to selected bidders at L-1 rate for another one year.

(vi) **PCCF (Development) has the Authority to terminate the contract in following condition:-**

- Termination for default-** Fails to complete the work(s) or items of work with individual dates of completion, on or before the date(s) so determined, and does not complete them within the period specified.
- Termination for insolvency:-**At any time terminate the Contract by giving written notice to the Agency if he becomes bankrupt or otherwise insolvent.
