The bidders are advised to study the tender document carefully. Submission of bid shall be deemed to have been done after careful study and examination of the Tender Document with complete understanding of its implication. The tender should be accompanied with attested copies of Sales tax, PAN card, Vat clearance, GST registration and other essential documents along with an Earnest Money Deposit of Rs. 15,000/- (Fifteen Thousand only.) for bidding Dart Tranquillizer Gun in the form of a condition as mentioned in the tender document.

1. Instruction , Terms and Conditions for Invitation of Bids for supply of Dart Tranquillizer Gun

- 1.1 The Wildlife Division, Ranchi is intended to procure **Dart Tranquillizer Gun**. Therefore, the Office of Chief Conservator of Forest, Wildlife Ranchi, Jharkhand is looking for vendors who have experience in supplying of aforesaid equipment.
- 1.2 Bidders are advised to study all technical and financial aspects, instructions, terms and specification carefully in the tender document. Failure to furnish all information required in the tender document or submission of a bid not substantially responsive to the tender document in every respect will be at the bidder's risk and may result in the rejection of a bid.
- 1.3 Sealed offers are prepared in accordance with the procedure enumerated in "**Procedure for submission of bids**" section and it should be submitted to the Office of the Chief Conservator of Forest, Wildlife Ranchi, Block-A, Van Bhavan, Doranda, Ranchi, Jharkhand.
- 1.4 Please note that this is a tender and selection will be done after technical evaluation and financial evaluation. Financial bids will only be opened of the bidders who fulfil the technical qualifications.
- 1.5 Agencies/Firms/Organizations if found to have indulged in any corrupt or fraudulent practices their bids will not be taken up for consideration.
- 1.6 The agency/bidder shall be responsible for all the costs associated with the preparation of the bids. The Office of Chief Conservator of Forest, Wildlife Ranchi, Jharkhand shall not be responsible in any way for such costs, regardless of the conduct or outcome of this process.
- 1.7 Mere submission of bids does not entitle the agencies/bidders to meet technical criteria. The undersigned reserves the right to vet and verify any or all information submitted by the agency/bidder.
- 1.8 No exclusivity rights will be provided nor should be assumed by the agency/bidder at any stage.
- 1.9 The detailed schedule of events is as per this document. The Office of Chief Conservator of Forest, Wildlife Ranchi, Jharkhand shall not be responsible for non-receipt /non-delivery of the bid/bids due to any reason whatsoever.
- 1.10 This Tender document is not transferable and Tender notice published in Newspapers vides Tender Notice No. – 02/2019 is a part of this Tender Document
- 1.11 Consortium bids are not allowed.
- 1.12 The bids are required to be submitted on the agencies letter head with due signature at every page.
- 1.13 Bid for supply of "Dart Tranquillizer Gun" must be accompanied by a bid security of deposit Rs. 15,000/- in the form of demand draft from any nationalized bank in favour of Chief Conservator of Forest, Wildlife Ranchi, Jharkhand and payable at Ranchi. Bid security

amount is refundable on completion of the bid process. Tendered not accompanied by earnest money or incomplete in any respect will be rejected outrightly.

- 1.14 The category of items and quantity indicated in the tender document are tentative. The Chief Conservator of Forest, Wildlife Ranchi, Jharkhand reserves the right to decrease the quantity or delete some or all the items depending on the need without assigning reason thereof.
- 1.15 The bidders should indicate the price including all taxes, transportation cost and other charges payable.
- 1.16 The tender should clearly indicate the delivery period and validity period of the tender.
- 1.17 The tender should clearly indicate the availability of service centre and maintenance facility for the aforesaid equipment.
- 1.18 The Tender should clearly indicate the warranty/guaranty period the part Dart Tranquillizer Gun.
- 1.19 Prices must be quoted in Indian Currency Only.
- 1.20 The tender must be submitted along with the attested copies of
 - i. Manufacturers license or Tender specific authorization from Original Equipment Manufacturer.
 - ii. GSTIN, PAN Card, State/Centre TIN, Sales Tax return, Income tax Return of Last 3 years.
- 1.21 The Chief Conservator of Forest reserves the right to reject any or all tenders without assigning any reason whatsoever. It also reserves right to seek further information/details from the bidder (s).
- 1.22 The tenders will be open as per the schedule specified in this tender document in the presence of bidders if any present on the occasion.
- 1.23 All damaged or unapproved goods shall be returned at the risk and cost of the bidder and the incidental expenditure thereupon shall be recovered from the concerned party.
- 1.24 The offers/bid shall be unconditional.
- 1.25 On acceptance of tender, the date of delivery should be strictly adhered to otherwise, the Chief Conservator of Forest, Wildlife Ranchi, Jharkhand reserves the right not to accept the delivery in full or in part.
- 1.26 Tender will demonstrate the use of Dart Tranquillizer Gun at time of tender and also during delivery if he will be selected.
- 1.27 Payment of bill shall be made through the RTGS on supply of the goods and No advance payment will be made. The decision to purchase each item is taken independent of other items quoted by the bidder. It is not binding to purchase all the items quoted by any particular bidder.
- 1.28 In unforeseen circumstances, it is not binding to the Chief Conservator of Forest, Wildlife Ranchi, Jharkhand to purchase the equipment as mentioned in this tenders

document even after final selection of bidder and in this case, bidder can't claim any cost occurred in this process.

2. Procedure for submission of bids

2.1 It is proposed to have a two-cover system for this tender

- a) Technical Bid (in duplicate) in one cover.
- b) Financial bid (in duplicate) in one cover.

2.2 Each copy of technical bid of the tender should be covered in a separate sealed cover super scribing the wordings “**Technical Bid for Dart Tranquillizer Gun**” separately. Each copy should be marked as “Original Copy” and “First Copy”. Both should be put in a separate cover super scribing the wordings “Technical Bid for Tranquillizer Gun”.

2.3 Each copy of the financial bid of the tender should be covered in a separate sealed cover super scribing the wordings “**Financial Bid for Dart Tranquillizer Gun**”. Each copy should be marked as “Original Copy” and “First Copy” of both should be put in a separate sealed cover super scribing the wordings “Financial Bid for Dart Tranquillizer Gun”. Financial Bid should only indicate prices.

2.4 All the two documents viz. Technical Bid Cover and Financial Bid Cover prepared as above are to be kept in a single sealed cover separately subscribed with “Dart Tranquillizer Gun” in a separate sealed cover scribed.

2.5 The cover thus prepared should also indicate clearly the name and address of the bidder to enable the bid to be returned unopened in case it is declared “late”.

2.6 The Earnest Money is paid by Demand Draft, the draft must be in a separate sealed envelope indicating the amount, tender Notice Number and due date and enclosed with the Bid.

3. Tender Document

This Tender document comprises of total **21 pages**. In addition, any other documents/instructions/amendments/revisions issued by the Office of the Chief Conservator of Forest, Wildlife Ranchi, Jharkhand to the bidder till the due date of opening of the bids shall also be deemed to be integral part of the Tender document. Failure to furnish all the information as per the Tender document in every respect will be at the bidder's risk.

4. Clarification of Tender Document

A prospective bidder requiring any clarification of the tender document may notify the Office of Chief Conservator of Forest, Wildlife Ranchi, Jharkhand in writing at the ccfwildliferanchi@gmail.com mailing address. The Chief Conservator of Forest, Wildlife Ranchi, Jharkhand may respond in writing to any request for clarification of the tender document, received not later than 02 working days prior to the last date for the receipt of the bids prescribed by the client. In case of any further clarification on any of the points in the

tender, if required, a meeting can be held. However, Chief Conservator of Forest, Wildlife Ranchi, Jharkhand reserves the right not to respond to any query or provide any clarification, in its sole discretion, and nothing in this clause shall be construed, taken or read as compelling or requiring Chief Conservator of Forest, Wildlife Ranchi, Jharkhand to respond to any query or to provide any clarification.

5. Amendment of Tender Document

- 5.1 At any time prior to the last date for receipt of bids, the client may for any reason, whether at its own initiative or in response to a clarification request by the prospective bidder, modify the tender document by an amendment.
- 5.2 The amendment will be notified in writing or E-mail to all prospective tenders who have received the tender document and will be binding on them.
- 5.3 In order to afford prospective bidders reasonable time in which to take the amendment into the account in preparing their bids, the Client may, at its discretion, extend the last date for the receipt of the Bids.

6. Earnest Money

- 6.1 Bid for supply of “Dart Tranquillizer Gun” must be accompanied by a bid security of deposit Rs. 15,000 (Fifteen Thousand Only) for each item mentioned above in the form of demand draft from any nationalized bank in favour of Chief Conservator of Forest, Wildlife Ranchi, Jharkhand and payable at Ranchi. Bid security amount is refundable on completion of the bid process. Tender not accompanied by earnest money or incomplete in any respect will be rejected out rightly.
- 6.2 The earnest money shall be returned to all unsuccessful bidders, within thirty days from the date of completion of tender process.
- 6.3 The earnest money shall be forfeited if the bidder fails to successfully supply Dart Tranquillizer Gun within the stipulated time period.

7. Evaluation of Bids

Received Technical and Financial bids will be evaluated separately in two stages. In Stage-I Technical bids of all the bidders shall be evaluated first on a given time & date as per the schedule of events. The tenderers or his authorized representatives maybe present during this time if he so wishes. In Stage-II Financial Bids shall be in likewise manner evaluated on the given date and time as per the schedule of events. The Financial Bids of only those bidders will be opened and considered who shall be declared technically qualified during first stage evaluation i.e. technical evaluation.

Stage-I: Prequalification Cum Technical Bid

A bidder would be declared technically qualified for the consideration of financial bid (Financial evaluation) if he meets the following terms and conditions: -

Stage-II: Financial Bid

Financial Terms and conditions

Chief Conservator of Forest, Wildlife Ranchi, Jharkhand will evaluate the financial bids received from the technically qualified bidders. During evaluation of financial bids, Chief Conservator of Forest, Wildlife Ranchi, Jharkhand may at its discretion, ask the bidders for clarification of their bids. The bidder should submit the financial bid in Performa as per **Annexure-2**.

- (i) **Evaluation Method of Financial Bids:** Technical bids of all the bidders will be examined first. Financial bids of only those bidders, who will be found to be fulfilling the technical criteria, will be evaluated. The Technical bid of all the bidders and financial bid of qualified bidders as per technical criteria will be opened as per the details regarding date and time mentioned in the tender Notice No 02 /2018.

8. No Claim or Compensation for Submission of bid

The bidder whose agency is not selected shall not be entitled to claim any costs, charges or expenses in connection with his submission of bid, even though Department of Forest, Environment & Climate Change, Government of Jharkhand may decide to withdraw the Notice Inviting tender.

9. Jurisdiction of the Court

All disputes would be settled within Ranchi jurisdiction of Court of law only.
