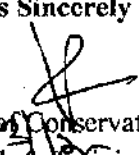
Sir,

You are requested to participate in the workshop positively.

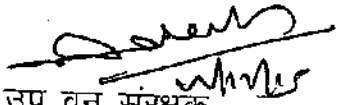
