Design, Implement and support “UAV surveillance system” for strategic locations at Palamau Tiger Reserve. The management intends to deploy UAV in the strategic locations in Palamau Tiger Reserve for surveillance and long term aerial mapping purposes and Monitoring tigers straying in the vicinity of reserve. Besides it will also help in reducing man-animal conflict and illicit felling activities.

The key objective of the system will be to provide accessibility to the remote areas using unmanned surveillance system. The system should be based on UAV technology to support seamless surveillance to ensure minimal setup and interference in the Forest.

The System should be comprised of 3 UAVS.

- One multirotor with zoom camera with minimum 20x optical zoom capability.
- One multirotor with thermal camera.
- One fixed wing plane for long term mapping of the forest with Sony QX1 camera and stitching software.

CHAPTER II: UNDERTAKING OF THE TENDERER

CHAPTER-III :INSTRUCTIONS FOR TENDERER

1. Department of Forests and Environment, Government of Jharkhand Invites sealed offers for the “UAV Surveillance System” at Palamau Tiger Reserve Jharkhand from IT Service Providers.
2. Tenders should only be dropped in the tender box kept in the **Office of Field Director, Palamau Tiger Reserve, P.O. Daltonganj Dist., Palamau – 822101**, on or before 10/02/2017 till **1.00 PM**. Tenders received after the time and dates shall not be considered. Covers should invariably be super-scribed “**UAV Surveillance System**” at **Palamau Tiger Reserve, Jharkhand & also name of the tenderer in block letters**.
3. **Eligibility and qualification criteria:**
 - A. The bidder shall meet the following requirements:
 - (iv) The bidder should have consistently strong financial performance
 - (v) Bidder shall furnish Service Tax, CST, Sales Tax, VAT registration no. along with the IEC Code number if applicable.
 - B. The bidder should have experience in required technology applications
 - C. The bidder should have either experience of working with private bodies or State or Central Government
 - D. The bidder should be backed by State or Central Government Institutions and must show proof of developing similar technology in participation with State or Central Government Institutions
- (vii) Firms black listed by Government of Jharkhand are barred from participating in this tender
- B. The documentary evidence for meeting the eligibility criteria must mandatorily be submitted along with offer.
4. Bid should be submitted in two cover system containing two parts as detailed below

Part I: Technical bid to be kept in the sealed cover marked as “**Technical Bid**”.

Part II: Commercial bid to be kept in the second sealed cover marked as “**Financial Bid**”

Technical Bid: The Technical bid shall contain the technical specifications of all the instruments /equipment’s/software/structures which will be used for UAV Surveillance System, documentary evidences for meeting the eligibility criteria and qualification in envelop, filled tender forms and the EMD DD.

Financial Bid: The Financial bid shall contain only the rates offered by the bidders for UAV Surveillance System.

The Technical Bid will be opened and eligible bidders meeting all the requirements will be short listed. The bidders may be required to give presentation of their solution before the **technical committee** constituted for this purpose. Thereafter, Financial Bid of only short listed bidders will be opened. The date of opening financial bid will be informed to the short listed bidders. All bidders are requested to mention their Email-ID and mobile contact number on the cover of the envelope containing Bid documents.

Successful Bidder will be required to sign Memorandum of undertaking (MOU) in connection with implementation/Installation of the project. The MOU will include availability of Service Centre and Service Engineer, Standard of Performance, Use of Contract Documents performance contract etc.

5. Bidders are required to quote rates including all the taxes and duties. Rates should be quoted F.O.R. door delivery basis at the desired site of Palamau Tiger Reserve, Jharkhand including installation and testing. The rate should be written only in prescribed form enclosed with the tender document. No price preference shall be given to the bidder for this tender.
6. The selected bidder should deploy "UAV Surveillance System" within 45 days from the date of issue of sanction order. If the bidder fails to deliver and install system to perform the services within the period specified in terms and conditions of the tender document the purchaser shall without prejudice to its other remedies shall deduct 1% per day and maximum deductions shall be 10% of the order value, as liquidated damages, or the delivery price of the delayed goods or unperformed services for each day of the delay until actual delivery or performance. Once the maximum is reached the purchaser may consider termination of contract. The decision on delay and circumstances shall be taken by the Field Director, Palamau Tiger Reserve Jharkhand or any other competent authority.
7. Account Payee Demand Draft, Fixed Deposit Receipt or Bank Guarantee of Rupees 150000/- (Rupees One Lakh fifty thousand only) in favour of Field Director, Palamau Tiger Reserve, payable at Medininagar from any Nationalised Bank is to be submitted along with the tender as Earnest Money Deposit (EMD). Unsuccessful bidder EMD shall be released after finalization of tender and for the successful bidder EMD shall be released after receiving the Performance Security Deposit.
8. Successful Bidder shall be required to submit Account Payee Demand Draft, Fixed Deposit Receipt or Bank Guarantee on any scheduled bank @5% of the total price quoted for the project as a Performance Security Deposit.
9. The bid should reach to the authority within the specified time frame. No bid shall be accepted after the last date and time for receiving the bid.
10. The bid shall be submitted as per the terms and conditions as laid down in the tender document. If any bid found faulty shall liable to be summarily to be rejected.
11. Successful bidder has to submit project execution summary phase wise payment shall be done based on work evaluation.
12. Liquidated damages may be imposed for defaults/inordinate delays on the part of the supplier.
13. No representation shall be accepted after opening of the tender.
14. The Field Director, Palamau Tiger Reserve, Jharkhand reserves the right to change the date and time of tender opening.
15. The Field Director, Palamau Tiger Reserve, Jharkhand also reserves the right to accept, reject or cancel tender without assigning any reason.
16. All the payment shall be made after deducting all taxes, surcharges etc. which are payable to government as Tax deduction or source (TDS). Any Tax exemptions shall not be given or entertained in this office.
17. Successful bidders shall be there to provide operational and training support for the UAV system for 2 months after Completion of the installation. Bidder shall also provide monthly/Yearly cost bid of extending this support period.
18. Bidder shall provide detailed warranty conditions for all equipment used.
19. In the event of any dispute, Field Director, Palamau Tiger Reserve, Jharkhand Shall be the arbitrator authority and his decision shall be binding on both parties and no further appeal shall be entertained.
20. All the disputes are subjected jurisdiction of Jharkhand court.

ADDITIONAL SPECIAL CONDITIONS FOR TENDER DOCUMENT DOWN LOADED FROM WEBSITE.

- a) Tenderers may note that permitting of downloading of tender document is an added facility for convenience of Tenderer/s. Field Director, Palamau Tiger Reserve Jharkhand however, reserves right to extend this facility for selected works or continue only with direct sale of tender forms. In case, tender document is not uploaded on website or download failure or delay or incomplete document downloaded, whatsoever, Field Director, Palamau Tiger Reserve Jharkhand shall not be responsible in anyway. Field Director, Palamau Tiger Reserve Jharkhand shall not be responsible for any direct/indirect loss of business/profit resulting from inability to use this facility.
- b) The Tenderer/s shall download & print the Tender document solely for bidding for above work and downloaded document shall not be used, copied or reproduced for any other purpose.
- c) The end of tender document is indicated by "End of Tender Document" marker. Tenderer/s should carefully see that above marker appears on the last page of downloaded tender document to ensure that downloaded document is complete. Tenderer is suggested to check the integrity and completeness of document before submission.

- f) The Tenderers are required to pay non-refundable cost of tender document in the form of demand draft drawn on any nationalised bank in favour of **Field Director, Palamau Tiger Reserve, Jharkhand** payable at Jharkhand while submitting their offer. In case they fail to furnish the requisite cost of tender document in prescribed form, their offer shall be rejected. The cost of EMD shall not be merged with cost of tender form and shall be separately furnished.
- g) The Tenderer/s shall maintain the integrity of downloaded tender document and shall not make any change/addition/deletion/tampering, whatsoever, in the downloaded documents. The Tenderer/s offer shall be rejected and full earnest money shall be forfeited, in case it is detected after submission of offer, that they have made any modification in downloaded documents. In case such modification is noticed even after award of contract, Field Director, Palamau Tiger Reserve Jharkhand is liable to terminate the contract on contractor's default. In addition, Field Director, Palamau Tiger Reserve Jharkhand reserves the right to take action against the firm as deemed fit, which may include Banning of Business Dealings with the firm and the firm is also liable to be prosecuted as per the law. After award of work, agreement, wherever necessary, will be prepared based on the master copy of tender document available in the mentioned office. In case, any discrepancy is noted in tender document submitted by Tenderer, the Master document kept with authority shall prevail and decision of Field Director, Palamau Tiger Reserve Jharkhand thereon shall be final and binding on Tenderer/Contractor.
- h) Tenderer/s shall print the tender document on good quality A4 size papers and printed document shall be clearly legible. The document shall be properly bound and

page numbers shall be in serial order as mentioned in downloaded documents. The Tenderer/s shall not be reimbursed with the cost of stationery, printing and binding etc. Offer of Tenderer/s is liable to be rejected by Field Director, Palamau Tiger Reserve Jharkhand if tender document is not printed or bound as per above instructions. Further, Tenderer shall bear expenses of Internet connection and telephone charges, if any for downloading of tender document.

- i) The Tenderer/s shall keep themselves updated about any modification in tender notice and tender document issued by authority through newspapers, website or E-mail or any other means and shall act accordingly. It is the responsibility of the Tenderer to check any correction or any modifications published subsequently in Web site and the same shall be taken into account while submitting the tender. CHAPTER-IV : Technical Bid
Tender Specifications of the "Design, Implement and Support UAV
Surveillance System" at Palamau Tiger Reserve

Design, Implement and support UAV Surveillance System for Palamau Division area for monitoring of tigers.

The key objective of the system will be to provide accessibility to the remote areas using unmanned surveillance system.

The System should Comprise of 3 UAVs with following specification.

MultiRotor with zoom camera: Two units of Quadcopter /Octacopter are required with following features. One unit should have daylight zoom camera as payload and second unit should have thermal camera as payload.

- Minimum Flight time with camera payload included : 25 minutes
- Full autonomy. The drone should have GPS and be capable of doing autonomous missions.
- Multirotor system should be capable of doing a top speed of at least 15m/s while maintaining excellent stability.
- Multirotor system should be operable in winds as high as 50kmph.
- Failsafe options for “out of range” or “battery low” like conditions are must. System should provide RTL(return to launch) or Land options in such case.
- Visual Daylight camera Requirement
 - Min camera resolution: 1080p
 - Min optical zoom for camera: 20x (digital zoom should not be counted in this)
 - Camera zoom should be controllable from Ground station application or radio controller.
 - Camera pitch should be controllable from ground.
 - Camera should provide live view down to ground station.
 - Camera should always record full resolution video on board the camera irrespective of live view.
- Thermal camera requirement:
 - Min resolution: 320p
 - Camera pitch should be controllable from ground.
 - Camera should provide live view down to ground station.
 - Camera should always record full resolution video on board the camera irrespective of live view.

- FLIR Tau series camera is preferred but any other camera that satisfying the above specification will be acceptable.

Mapping fixed wing UAV/Plane Requirements:

- Min Flight time: 1 hour.
- Camera: Sony QX1 with prime lenses or equivalent full frame camera.
- Either standalone software or online service subscription of atleast one year should be provided for stitching the images taken with this UAV.
- Plane should be able to operate in 50kmph wind conditions.
- Mapping missions and software support is must for fixed wing UAV.

Antenna tracker and operational requirements:

- All UAVs should use common autopilot and communication technology.
- The controller should have a standalone range of minimum 2 kms. But the equipment for all three UAVs should be pluggable to antenna tracker for range extension upto 10kms.
- Antenna Tracker should be tripod mounted and portable.
- All equipment should come in hard case for easy transportation from one place to another.
- The communication technology used should only use ISM license free frequency bands and should honour radiated power regulatory requirement in their respective bands.

Support Requirement:

- Minimum 4 months of onsite support has to be provided for operation and training purposes. At least one person should be deployed onsite at **Palamau Tiger Reserve** for this purpose. This period is in addition to any installation period that might be required. So, this support period starts from the days when all systems are operational.
- All equipment should be accurately rated in terms of its flight time life / operational life and warranty in the bid.
